

## FOREST FACILITY LTD ACCEPTANCE OF ADVENTURE ACTIVITY TERMS AND CONDITIONS

- 1. I understand and acknowledge that by my entry into this activity I agree to abide by the Forest Facility Ltd's Terms and Conditions of Entry in their entirety, as presented to and agreed by me at the time of booking. A copy is available to view in the Registration Office.
- 2. Adventurous Activities are dangerous sports with inherent risks, which you must acknowledge and accept. Partaking can cause serious injury or death.
- 3. Our public liability insurance is applicable if incidents occur as a result of our negligence or equipment failure, however please note, there is no insurance cover for personal accident. Should you have an accident, of any description whilst partaking in any activity with us, you will not be insured through ourselves, such insurance is not currently available in the UK. If you wish to be insured, you must obtain your own personal accident and injury insurance BEFORE undertaking in an activity. If you chose to participate without adequate personal insurance cover in place, we will not be liable to you for any losses howsoever arising where cover would otherwise have been available (except where these are incurred as a result of our negligence).
- 4. By signing and accepting these conditions of use you acknowledge:
  - i. That there is no form of personal accident insurance cover provided by us
  - ii. That you undertake any adventurous activity entirely at your own risk.
- 5. You accept that you, or anybody acting on your behalf (to include your relatives and/or your beneficiaries), will not make or attempt to make any claim against us should accident, injury or death occur.
- 6. You also undertake and confirm that:
  - a. You can abide by the rulings set out for any of the Adventurous Activities on site.
  - b. You have no known medical impairment or reason why you should not be able to undertake any activity safely. You will wear protective equipment as set out by instructors which is provided at all times.
  - c. You will follow instructions from staff immediately and without question.
  - d. You are not under the influence of alcohol or drugs.
  - e. You will treat all equipment with the utmost respect.
  - f. You will respect other people partaking in activities.
- 7. We accept no liability for any injury, loss or damage caused to persons or possessions on these premises to include the car park, changing rooms and any adventurous activity areas.
- 8. You will be held liable for any damage caused to any equipment (and any associated costs and losses arising from damage) during your session due to misuse.
- 9. We reserve the right to refuse any person from partaking in any adventurous activity, and we reserve the right to immediately terminate your session at any time without providing a reason or a refund. For the purposes of this Agreement and the foregoing, the definition of 'you' is the customer partaking in an activity.
- 10. **Structures and Obstacles:** I understand Forest Facility includes many different types of challenges, all of which are optional i.e. I can choose not to do them if I am unsure of the safe method of engagement or not confident in my own ability to do so safely. I will; follow the rules and guidance given to me by staff involved in the challenges, be patient if any queues develop, follow the on-site routing and activity sequence in the way intended, NOT make actions or manoeuvres that frustrate or endanger others. I will not carry loose items on this activity e.g. keys, cameras, phones.
- 11. **Injuries:** I understand that, whilst every care is taken to ensure my safety, due to the challenging nature of the Forest Facility activities, it is possible I may suffer some minor bumps, bruises, or abrasions by taking part.



- 12. **Water, Mud, Other Substances and Hygiene:** I understand that some activities may feature immersion in water and the use of mud and other natural and non-natural substances. I accept that (whilst Forest Facility have taken all reasonable precautions to check water quality) they are not liable for the quality of static bodies of water as this can never be guaranteed. Likewise, I accept that Forest Facility is not liable for any mud and/ or other substances used in this Event harbouring some levels of naturally occurring bacteria which could lead to illness if ingested. I understand that I must cover open wounds prior to taking part in activities.
- 13. **Photography and Film:** I understand that under the Forest Facility Terms and Conditions, I have consented to my likeness being used for the transmission of film and/ or photography by Forest Facility and/ or their agents, including for the purposes of the transmission of footage on TV. I agree that all photography or film that I capture at Forest Facility will be for personal use only.
